## 1. Position: Director General – TIB Rasilimali Limited

### 1.1 Position Overview

The Director General is the principal executive officer of TIB Rasilimali Limited and is responsible for providing strategic leadership and overseeing the day-to-day operations of the company. The role ensures sustainable growth, profitability, regulatory compliance, and delivery of high-quality capital markets and investment services in support of TIB Development Bank's development finance mandate.

### 1.2 Key Duties and Responsibilities

- Advise and regularly report to the Board on strategic and operational performance.

- Lead stakeholder engagement, brand positioning, and public representation of the company.
- Identify and develop new business opportunities to enhance revenue and market presence.
- Ensure timely preparation of accurate financial statements and achievement of unqualified audit opinions.
- Support and complement TIB Development Bank's development financing role in Tanzania.
- Perform any other duties as may be assigned by the Board from time to time.

## 1.3 Minimum Qualifications and Experience

### 1.3.1 Academic Qualifications

- Master's degree in Finance, Insurance, Economics, Business Administration (MBA), Banking, Investment, Accounting, Capital Markets, or a related field from a recognized institution.
- Bachelor's degree in a relevant discipline from a recognized institution.
- Professional qualifications such as **CFA**, **CPA (T)**, **ACCA**, **CISA**, or any CMSA-recognized certification will be an added advantage.

- At least **ten (10) years** of relevant work experience in financial services, capital markets, investment management, insurance, banking, or development finance.
- Minimum of **eight (8) years** at senior management or executive level in a regulated financial institution.
